Training:

How do I find out where in-person training is offered?

How do I sign up for online training?

You can sign up for online training on the GI-BMP Training Website. The cost is \$15. (https://gibmp.ifas.ufl.edu/)

Do you offer Spanish Training?

Beginning in December, Spanish language training will be available online and on DVD. Spanish training and testing is currently through in-person classes only. A listing of in-person trainings can be found on the GI-BMP Training website under Training Schedule. The schedule can be filtered to easily locate Spanish classes.

Certification:

What is the quickest way to become GI-BMP certified?

Taking the Online Training and Test is the quickest way to obtain your certificate. Once you have passed your test, your certificate will be mailed within 1-2 business days and a pdf scan can be sent via email to the Trainee upon request.

I took the class and passed the test. When will I receive my certificate?

If you took the online test, your certificate will be mailed within 1-2 business days. For those who took an in-person test, the results are usually mailed within 10 business days of the testing date.

I lost my certificate. How do I get a new one?

I think I may already be certified. How can I tell?

Click "Certification List" on the sidebar of the GI-BMP Training Website (https://gibmp.ifas.ufl.edu) to view a list of everyone certified since 2006, arranged by county. If you don't see your name, it may be listed under a previous work address or your home county.

To correct information that has changed, click the Update Your Information link and complete the online form. (http://fyn.ifas.ufl.edu/professionals/BMP_contact_update_form.htm)

I took the GI-BMP training several years ago. Is my certificate still valid?

FDACS accepts GI-BMP Certification received in 2006 or after. Some counties and municipalities require re-certification based on local ordinances.

Limited Commercial Fertilizer Applicator Certificate (LCFAC) FAQs:

When is the deadline to have a fertilizer license?

The deadline to have a Limited Commercial Fertilizer Applicator Certificate (LCFAC) is January 1, 2014.

What do I need to apply?

Requirements for application (as listed on the FDACS application form):

- The certificate number from your GI-BMP training certificate of completion
- A current, clearly recognizable, full face, head and shoulders photograph measuring approximately 1-1/2 x 1-1/2 inches in size even if already on file.
- A \$25.00 fee

How do I get the application?

You can now apply for the Limited Commercial Fertilizer Applicator Certificate online by going to https://aesecomm.freshfromflorida.com/

You can also call FDACS at 850-617-7997 and request an application or download the application form at: http://forms.freshfromflorida.com/13677.pdf. The application is in Forms & Publications under "Application For Limited Certification For Urban Landscape Commercial Fertilizer (FDACS-13677)"

How do I know if I need a fertilizer license? Who enforces the deadline?

Florida law requires all persons who make fertilizer applications commercially ("for-hire") to have the Limited Commercial Fertilizer Applicator Certificate (LCFAC) from FDACS by January 1, 2014 (Florida Statute 482.1562).

Do I need to provide proof of liability insurance to obtain my commercial fertilizer license?

No, you do not need proof of liability insurance to make application.
