# Florida-Friendly Landscaping™ New Construction

This award recognizes a new residential or commercial landscape that adopts environmentally sound landscape, irrigation, and management policies that include Florida-Friendly Landscaping™ principles. The jury will consider the design, installation, and maintenance of the landscape based upon the Florida-Friendly Landscaping™ checklist for new construction.

Typical Entries Include: Commercial, governmental, and multi-family new construction that have recently installed a Florida-Friendly landscape. Nominees may self-submit or may be nominated by others.
